The aim of the School for Public Health and Primary Care: Caphri is: High-quality research and teaching focused on health care innovation, ranging from prevention to rehabilitation, from a patient, professional and societal perspective, leading to improvement of health and well-being of the population. Research and teaching are devoted to contribute to improvements in the area of public health and primary care. The School focuses on interventions in the chain of care, starting with prevention and primary care, and ending with aftercare and rehabilitation. The aim of the research is to get insight into the effectiveness of interventions, and their adequacy in meeting prospective patients' needs. Specific attention is paid to the implementation of such evidence based interventions. Interventions are also evaluated from an economic perspective (Health Technology Assessment) and a normative perspective (e.g. consequences for professional and patient roles and responsibilities).
